

# Southwestern Michigan College Board of Trustees Meeting Minutes

## **General Business**

Members of the Southwestern Michigan College Board of Trustees met on April 12, 2023 for a regularly scheduled meeting.

The meeting was convened at 8:00 a.m. by Board Chairman Tom Jerdon.

The Pledge of Allegiance was recited.

Minutes of the March 8, 2023 regular convened meeting required no changes and were placed on file.

Keith McKenzie moved, seconded by Becky Moore, to approve the agenda. Motion passed unanimously.

One individual was recognized for their service at the College: Ms. Caroline Price was recognized for her years of service and Keith McKenzie presented her with a 5-year pin.

#### Other

The Treasurer's Report for the month ending March 31, 2023 was received and placed on file.
